

**RELEASE OF LIABILITY AND
ACKNOWLEDGMENT AND ACCEPTANCE OF
DANGERS, RISKS, AND HAZARDS OF HUNTING LEASE**

1. I hereby acknowledge that as a member of the Cresaptown Sportsman Club, I am permitted to hunt on the Property that is subject to a Hunting Lease dated August 22, 2014 (the "Hunting Lease") that the Sportsman Club has entered into for the benefit of its members. I understand that my presence upon the Property is subject to the terms of the Hunting Lease, which I have read. I understand the terms, provisions and conditions of the Hunting Lease and will abide by its terms, provisions, and conditions. Capitalized terms used in this document have the meanings given to them in the Hunting Lease.

2. I further acknowledge and understand no warranty, either expressed or implied, is made by Lessor as to the condition of the Property or any roads, buildings, gates or other improvements located thereon. This document is sufficient warning that dangerous conditions, risks and hazards may exist. My presence and activities on the Property expose me and my personal property to dangerous conditions, risks and hazards, including but not limited to: poisonous snakes, insects and spiders; blinds and tree stands; erosion and the general condition of the land, both on and off roadways, creating rough, hazardous and dangerous driving and walking conditions; animals both wild and domestic that may be diseased and/or potentially dangerous; and persons with firearms both on or off the Property. I hereby expressly assume all such dangers, risks and hazards.

3. The Property upon which permission to hunt is granted is subject to a Wind Energy Lease. Wind farm personnel may be on the site at any time and appropriate caution must be taken to protect the safety of such personnel. As a safety precaution, Wind Energy Lessee, as lessee under the Wind Energy Lease, as well as any other person on the Property for any purpose associated with the Wind Energy Lease, may temporarily suspend the privilege to hunt on the Property or restrict the area upon which hunting is permitted without prior warning. While on the Property, I shall comply with all written or verbal instructions of any person who advises that he or she is on the Property for any purpose associated with the Wind Energy Lease. I understand that ice can develop on the wind turbines in certain weather conditions and that it can fall off, or be blown off by wind. It is my responsibility to stay far enough from any turbine on or near the Property to avoid being struck by ice. It is also my responsibility to avoid causing damage to the wind turbines and any other buildings or equipment at the Property. I will refrain from leaving gut piles and other animal remains within 150 yards of any wind turbine.

4. In consideration for the right to enter the Property, I hereby release and agree to protect, indemnify and hold harmless Lessor and Wind Energy Lessee and their respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorney fees, resulting from any accident, incident or occurrence arising out of, incidental to or in any way resulting from my use of the Property and any improvements thereon, whether or not caused by Lessor's or Wind Energy Lessee's negligence or gross negligence. I hereby further covenant and agree that I, my heirs, successors and assigns will not make any claim or institute any suit or action at law or in equity against Lessor, Wind Energy Lessee or their agents, representatives, employees, successors in interest or office, or assigns.
